Traffic Lights in West Melton on to B 6097 Elsecar Road 1xM  
continue on Elsecar Road and bear left into Coaley Lane 1xM  
continue along Coaley Lane to turn left and complete one lap at  
junction with b 6090 Cortworth Lane. 2xM

**FINISH :-** Coaley Lane, just before brow of hill in Lee Wood.
